#### **BACKGROUND**

The El Dorado County Transit Authority (El Dorado Transit) staff reports monthly and year-to-date ridership trend reports at each Board meeting.

#### **DISCUSSION**

February 2017 ridership decreased systemwide from 29,148 to 26,807 one-way passenger trips or -8.0% compared to the previous year. February 2017 had one (1) less weekday compared to the previous year, which may have accounted for the decrease in ridership.

Year-to-date ridership for the period July 1, 2016 to February 28, 2017 decreased from 225,960 to 225,260 one-way passenger trips or -0.3% compared to the previous year.




