- 1. Approve Purchase Order 23207 issued to Next Level Warehouse Solutions in the amount of \$7,040.73 for the purchase of a Pallet Racking System
- 2. Authorize the Executive Director to execute all contracts and documents included in the Adopted Capital Improvement Plan 17-05 budget

#### **BACKGROUND**

The El Dorado County Transit Authority (El Dorado Transit) operates a maintenance shop to perform all repair and maintenance to fleet vehicles excluding major body repairs, paint and windshield installation. The facility includes three (3) large bays and repair stations to allow for multiple repairs to occur simultaneously.

On June 2, 2016 the Board of Directors approved Capital Improvement Project No. 17-05 Maintenance Facility – Safety and Equipment which included a Pallet Racking System for the maintenance facility.

El Dorado Transit Purchasing Procedures and the Joint Exercise of Powers Agreement establishing El Dorado Transit require Board approval for Purchase Orders over \$25,000 and Purchase Requisitions over \$5,000. Although this purchase order does not meet the standard threshold for Board presentation; all Capital projects are typically presented.

The Executive Director certifies that these purchases are included within the Adopted Capital Plan and budget for Fiscal Year (FY) 2017/18.

#### **DISCUSSION**

Due to the various models of the fleet vehicles additional space is needed to store replacement parts. Space is also needed for special tools used for repairs for example a welding table, parts

cleaner and tire balancer. These are encroaching upon the work space and requiring maintenance staff to move equipment and supplies out of the way to perform their regular work. The installation of a pallet racking system will recover floor space in the maintenance shop and provide a safe location for spare parts, tires and other equipment to safely be stored.

### FISCAL IMPACT

Purchase Order amount is within budget line item as presented on the Final Capital Budget FY 2017/18 adopted on May 4, 2017.
