<u>REQUESTED ACTION:</u> BY MOTION,

- 1. Approve updated Purchase Order No. 27194 issued to A-Z Bus Sales in the amount of \$95,337 for the purchase of one (1) Ford Transit van
- 2. Approve the updated Capital Improvement Plan Project #20-06
- 3. Authorize the Executive Director to execute the purchase contract and related documents necessary to complete the Capital Improvement Plan Project #20-06 provided that the contract costs do not exceed the approved Capital Improvement Plan project budget

BACKGROUND

On October 3, 2019, The El Dorado County Transit Authority (El Dorado Transit) Board of Directors approved the Capital Improvement Plan (CIP) Project #20-06 for the replacement of one (1) 2013 Dodge minivan in its demand response fleet with an accessible Ford Transit van. The Ford Transit model would be the first of its kind in the El Dorado Transit fleet and can be configured with seating capacity for up to eight (8) ambulatory passengers, two (2) wheelchair securement positions and a side-door lift. In addition to improved reliability, the new larger model van offers more passenger capacity than a minivan and better fuel efficiency than a traditional cutaway bus, allowing for more scheduling flexibility and improved cost effectiveness.

DISCUSSION

El Dorado Transit staff utilized the California Association of Coordinated Transportation (CALACT) Cooperative Agreement for purchasing. However, soon after approval of Purchase Order No. 27194 by the El Dorado Transit Board on February 3, 2022, CALACT announced that updated pricing for the Cooperative Agreement would be necessary due to manufacturer product shortages and price increases. The pricing update took months to complete, increased the total cost, and delayed the purchase of the new van.

El Dorado County Transit Authority February 2, 2023 Staff recommends issue of updated Purchase Order No. 27194 to A-Z Bus Sales for purchase of the Ford Transit van, approval of the updated Capital Improvement Plan Project #20-06, and authorization for the Executive Director to execute the purchase contract and related documents necessary to complete the Capital Improvement Plan Project #20-06 provided that the contract costs do not exceed the approved Capital Improvement Plan project budget.

FISCAL IMPACT

The following cost summary reflects the updated purchase amount quoted by the selected vendor and the addition of project revenue derived from the sales of retired 5310 vehicles, reserved for new purchases under the program.
