BACKGROUND

The El Dorado County Transit Authority (El Dorado Transit) staff reports monthly and fiscal year-to-date ridership trend reports at each Board meeting.

DISCUSSION

Following is the March 2020 monthly ridership table comparing the current fiscal year to the previous fiscal year. Due to the COVID-19 virus and social distancing regulations, Senior Day Care services closed on March 13, 2020 Mother Lode Rehabilitation Enterprises (M.O.R.E.) closed on March 16, 2020, Commuter services were decreased to four (4) buses in the morning and afternoon on March 23, 2020. Transit ridership has reduced in all areas of service.

March Ridership

Comparing March 2020 and 2019, Demand Response ridership decreased by 44.0%, Local Fixed Route ridership decreased by 30.5% and Commuter ridership decreased by 43.2%. Productivity decreased by 24.6% in passengers per revenue hour. Year-to-date ridership has decreased by 4,376 passenger trips or 1.6%. However, year-to-date passengers per revenue hour has increased by 5.4%.

Following is the March 2020 and fiscal year-to-date ridership reports, comparing the current fiscal year to the previous fiscal year.

In March El Dorado Transit recorded 9,645 Connect Card taps or 47.8% of all ridership. Following is the Connect Card Ridership Report for the past twelve (12) months with a graph





BACKGROUND

The El Dorado County Transit Authority (El Dorado Transit) adopted an investment policy on November 7, 1999 allowing investments in the State of California Local Agency Investment Fund (LAIF) and money market accounts.

El Dorado Transit investment policy requires quarterly investment reports to the Board of Directors.

DISCUSSION

Interest earnings for the LAIF and Money Market accounts for the first calendar quarter of 2020 equal \$9,835.48, total interest for all interest-bearing accounts earned for fiscal year (FY) 2019/20 equals \$39,712.73; this reflects an amount of \$6,203.93 under the adopted budget. These funds are budgeted and used as operating income. The investment report for quarter ending 03/31/20 is submitted for review and file.

FISCAL IMPACT

Account 4970.00-Interest Income will be adjusted in the FY 2019/20 Final Amended Budget to reflect actual revenues.

BACKGROUND

The El Dorado County Transit Authority (El Dorado Transit) purchasing procedures allow an exemption to competitive bidding per the following approved <u>El Dorado Transit Procurement</u> <u>Policies and Procedures Manual</u>:

"Chapter 3; Section 14 Sole Sources Procurements:

- b) Sole source procurement may be used only when the award of a contract is infeasible under small purchase procedures, sealed bids, or competitive proposals and at least one of the following circumstances applies:
 - 5. The unique nature of the property or service required precludes competitive bidding."

El Dorado Transit Purchasing Procedures and the Joint Exercise of Powers Agreement establishing El Dorado Transit require Board approval for Purchase Orders over \$25,000 and Purchase Requisitions over \$5,000. El Dorado Transit operates a fleet of sixty-six (66) vehicles and the fleet currently consumes an average of 5,938 gallons of unleaded gasoline and 11,207 gallons of green low sulfur diesel per month.

DISCUSSION

El Dorado Transit purchases green low sulfur diesel and unleaded gasoline from two (2) local commercial cardlock fuel vendors on a daily basis due to the proximity of the facilities and the availability of differing types of fuel. Transit Operators and maintenance personnel fuel vehicles during the hours of 5:00 AM to 8:00 PM Monday through Friday and from 8:00 AM and 5:00 PM each weekend. Additional fueling is necessary during special shuttle services such as the Fair Shuttle.

Fuel prices at commercial/retail fuel vendors typically fluctuate daily based on the market. As a result, vendors are precluded from providing El Dorado Transit a set contract price for fuel at the pump the way they might if they were delivering fuel to a facility on less frequent basis. This daily price fluctuation does not lend itself to competitive bidding procedures therefore; the El Dorado Transit Board has allowed an exemption from competitive bidding on fuel since 2000.

Due to the operational need for daily fuel purchasing at outside vendors and the unique nature of daily fuel price fluctuations, it is recommended that fuel procurement be identified as exempt from competitive bidding. With approval, purchase orders will be issued to the two (2) local cardlock vendors that have provided price quotes using a set amount per gallon above their cost. The Executive Director certifies that these purchases are included within the preliminary approved operating budget for Fiscal Year 2020/21.

FISCAL IMPACT

Purchase Order amounts are within budget line item amounts as presented on the Preliminary Operating Budget FY 2020/21 adopted on April 2, 2020.

NOW THEREFORE, BE IT RESOLVED; that:

- 1. The purchase of fuel is considered unique in nature due to the daily fluctuation in price and is hereby declared exempt from competitive bidding.
- 2. The Executive Director is authorized to purchase fuel from outside vendors.

BY MOTION,

1. Approve the update to the Adopted <u>El Dorado County Transit</u> <u>Authority Personnel Policies and Procedures Manual</u>

2. Adopt Resolution No. 20-15 Telecommute Policy

BACKGROUND

One of El Dorado County Transit Authority's key governance policies is the <u>El Dorado County</u> <u>Transit Authority Personnel Policy and Procedures Manual (Policy)</u>. The last revision to the Policy was on February 6, 2020.

In reviewing the Policy, staff determined an update was needed to include a Telecommute Policy for flexibility in providing a viable work option that, when appropriately applied, benefits the needs of El Dorado Transit and the employee.

The proposed Policy has been developed to be consistent with all federal and state laws in addition to consideration of the mission of El Dorado Transit to provide effective public transit services.

DISCUSSION

Telecommuting is defined as an alternate work mode in which the employee works in a designated area outside their principal work location.

El Dorado Transit considers the Telecommute policy as a new benefit that will provide a balanced and cost-effective work alternative for employees.

Examples of benefits include:

• Ability to function during an emergency when the principal work location is inaccessible

El Dorado County Transit Authority May 7, 2020 Agenda

- Ability to sustain essential functions during a public health emergency requiring social distancing and/or quarantine
- Reduced employee commute time and costs
- Decreased energy consumption, air pollution, traffic, and parking congestion
- Increased productivity, improved employee morale and job satisfaction
- Reduced absenteeism and turnover

The draft policy addition to the <u>El Dorado County Transit Authority Personnel Policies and</u> <u>Procedures Manual</u> is presented for consideration.

FISCAL IMPACT

Indirectly, El Dorado Transit could realize savings in reduced employee absenteeism, reduced turnover, and a reduced need for additional office space.

El DORADO COUNTY TRANSIT AUTHORITY TELECOMMUTE POLICY

Purpose

The purpose of the Telecommute Policy ("Policy") is to ensure that essential El Dorado Transit ("Transit") functions continue to be performed at an alternative location during normal operation or during an emergency situation. Transit will implement this Policy in keeping with Transit's mission and the respective Transit Department. This Policy is intended to provide clear guidelines to employees telecommuting.

Authority

The Executive Director or designee shall determine when a Telecommute Agreement ("TA" or "Agreement") may be offered to an employee. Any Agreement is subject to the terms and conditions set forth in this Policy below.

All Transit employees must have an approved Agreement before telecommuting. Transit may include additional telecommuting requirements, guidelines, or procedures, provided they are consistent with the intent of this Policy in any Agreement. Only the Executive Director or designee may determine whether an employee may be offered an Agreement to telecommute.

Eligibility/Criteria

- A. Telecommuting is not suitable for all employees and/or positions. The Executive Director or designee has the discretion to determine the employees and positions who may telecommute on a temporary basis or as needed, utilizing criteria that includes, but is not limited to:
 - 1. Transit's operational needs and the needs of employee's department and/or position.
 - 2. The potential for disruption to Transit's functions.
 - 3. The ability of the employee to perform his/her specific job duties from a location separate from his/her Transit worksite ('Alternate Worksite') without diminishing the quantity or quality of the work performed.
 - 4. The degree of face-to-face interaction with other Transit employees and the public that the employee's position requires.
 - 5. The portability of the employee's work.
 - 6. The ability to create a functional, reliable, safe, and secure Alternate Worksite for the employee at a reasonable cost.

- 7. The employee's supervisory responsibilities and the employees need for supervision, if any.
- 8. The ability to establish a consisted and enforceable Work Schedule.
- 9. Other consideration as determined by the employee's immediate supervisor, department head, and/or the Human Resources Manager.
- B. An employee may not be a good candidate for telecommuting if:
 - 1. Their work is entirely, or primarily, location-dependent, or requires access to resources that are not allowable or practical for a remote location.
 - 2. Their job requires daily face-to-face interaction with individuals (e.g., managers, customers, co-workers, the public, etc.)
 - 3. Their presence is required at his/her principal work location for coordination and participation in operational duties or functions.
 - 4. The employee has not passed probation (unless this requirement is specifically waived by the Executive Director).
 - 5. Other types of work or work schedules that do not allow them to be away from their principal work location for entire days or portions thereof.

Telecommute Assignment:

- A. Telecommute days and hours must be agreed upon in writing within a TA in advance with the employee's department head or designee. The actual telecommute days per week or month may vary depending on the nature of the work and may be amended at the discretion of the Executive Director or designee.
- B. An employee may only telecommute for the term as specified in the Agreement, unless otherwise extended by the Executive Director or designee in writing. Transit retains the discretion to terminate any TA prior to its expiration.
- C. Non-exempt employees who are eligible for overtime shall be assigned a Work Schedule in the TA, including rest and meal breaks. Any deviation from the Work Schedule must be approved in advance, in writing, by the employee's supervisor. Non-exempt employees must take meal and rest breaks while telecommuting, just as they would if they were reporting to work at their Transit worksite. Non-exempt employees may not telecommute outside their normal work hours without prior written authorization from their supervisor. A non-exempt employee who fails to secure written authorization before telecommuting outside his or her normal work hours may face discipline in accordance with the Transit's policy for working unauthorized overtime.

- D. Telecommuting employees are required to be accessible in the same manner as if they are working at their Transit worksite during the established telecommuting Work Schedule, regardless of the designated location for telecommuting, or "Alternate Worksite." Employees must be accessible via telephone, email, and/or network access to their supervisor and other Transit employees while telecommuting, as if working at their Transit worksite. Employees shall check their Transit-related business phone messages and emails on a consistent basis, as if working at their El Dorado Transit worksite.
- E. Employees telecommuting can work at a remote location during a regularly scheduled workday or portion thereof. Telecommuting employees are required to maintain an accurate record of all hours worked at the Alternate Worksite and make that record available to his/her supervisor upon request. Telecommuting employees shall record all non-productive work time on his/her weekly report.
- F. While telecommuting, employees shall adhere to the following:
 - a. Be available to the department via telephone and/or email during the employee's Work Schedule.
 - b. Have reasonably quiet Alternate Worksite free of distractions, with reliable and secure internet access.
 - c. All employee absences must be approved in advance in accordance with Transit policy and documented on the appropriate leave of absence request.
 - d. Employee may not use telecommuting as a replacement for dependent child or elder care.
 - e. Employee must notify their supervisor promptly when unable to perform work assignments because of equipment failure or other unforeseen circumstances.
 - f. If has provided Transit owned equipment or supplies, employees agree to follow the Transit's Policy for the use of such. Employees will report to their supervisor any loss, damage, or unauthorized access to Transit owned equipment or supplies, immediately upon discovery of such loss, damage, or unauthorized access.
 - g. Employee must ensure proper use of Transit equipment or supplies and limit use of such supplies for professional purposes. Transit owned equipment may only be used by the employee to whom the equipment is issued. Any access by 3rd parties is strictly prohibited.

Duties, Obligations and Responsibilities:

Employees must adhere to the provisions set forth in this Policy and the terms of the TA. Any deviation from the TA requires prior written approval from Transit.

A. All existing duties, obligations, responsibilities, and conditions of employment remain unchanged. Telecommuting employees are expected to abide by all Transit and departmental policies and procedures, rules and regulations, applicable Memoranda of Understanding, and all other official Transit documents and directives.

- B. Employees authorized to perform work at an Alternate Worksite must meet the same standards of performance and professionalism expected of Transit employees in terms of job responsibilities, work product, timeliness of assignments, and contact with other Transit employees and the public.
- C. Employees shall ensure that all official Transit documents are retained and maintained according to the normal operating procedures in the same manner as if working at a Transit worksite.
- D. Employees may receive approval to use personal computer equipment only in the event of an emergency or on another limited basis. Transit may also issue equipment at the discretion of the Executive Director or his/her designee.
- E. Transit shall not be responsible for costs associated with the use of computer and/or cellular equipment, including energy, data or maintenance costs, network costs, home maintenance, home workspace furniture, ergonomic equipment, liability for third party claims, or any other incidental costs (*e.g.*, utilities associated with the employee's telecommuting).
- F. Employees may receive a virtual private network ("VPN") account, as approved by the Executive Director or his/her designee.
- G. Employees shall continue to follow all practices, policies, and procedures for requests of sick, vacation, and other leaves of absences. Requests to work overtime, request vacation or flex time off from work must be pre-approved in writing by each employee's supervisor. If an employee becomes ill while telecommuting, he/she shall notify his/her supervisor immediately and record on his/her timesheet any hours not worked.
- H. Employees must take reasonable precautions to ensure their devices (*e.g.*, computers, laptops, tablets, smart phones, etc.) are secure before connecting remotely to Transit's network and must close or secure all connections to Transit's desktop or system resources (*e.g.*, remote desktop, VPN connections, etc.) when not conducting work for Transit. Employees must maintain adequate security protection on all such devices used to conduct Transit work from the Alternate Worksite.
- I. Employees shall exercise the same precautions to safeguard electronic and paper information, protect confidentiality, and adhere to all Transit policies regarding record maintenance and security. Employees must safeguard all sensitive and confidential information (in all formats) relating to Transit work as accessed from the Alternate Worksite. Employees must return all records, documents, and correspondence to Transit at the termination of the TA or upon request by their supervisor, manager, or Human Resources.
- J. A telecommuting Employee's salary and benefits will remain unchanged. Worker's Compensation benefits will apply only to injuries arising out of and in the course of

employment as defined by Workers' Compensation law. Employees must report any such work-related injuries to their supervisor immediately. Transit shall not be responsible for injuries or property damage unrelated to Transit work, including injuries to third persons, when said injuries occur at the Alternate Worksite.

- K. All of the telecommuting Employee's duties and responsibilities remain in effect. Prior to the approval of an Agreement, supervisors and employees shall agree upon a reasonable set of goals and objectives to be accomplished.
- L. Any breach of the Agreement by the employee may result in termination of the Agreement and/or disciplinary action, up to and including termination of employment.

Telecommuting Agreement

Employee Acknowledgement:

I, the undersigned employee ("Employee"), have read the Telecommute Policy and this Telecommute Agreement ("TA" or "Agreement") in their entirety and I agree to abide by the terms and conditions contained therein. I understand and agree that the TA is temporary and contingent upon Executive Director or designee approval. Approval does not imply entitlement to a permanently modified position or a continued telecommute arrangement.

I understand and agree that the TA is voluntary and may be terminated at any time. I further understand that El Dorado Transit may, at any time, change any or all the conditions under which approval to participate in the TA is granted, with or without notice.

I agree to and understand my duties, obligations, and responsibilities as described in my position's job description and agree that those duties continue for the period of telecommuting. I also understand it is my responsibility to provide adequate advance notification to my supervisor if I am unable to satisfy those duties for any reason. I also agree and understand that all El Dorado Transit policies and procedures applicable to me remain in effect for any period of telecommuting. If I fail to follow these policies and/or satisfy my position duties, I understand this Agreement may be immediately terminated.

The Agreement is valid from _______ to _____. I understand this Agreement expires on _______ and may not continue unless El Dorado Transit approves a new TA in writing. El Dorado Transit may rescind this Agreement at any time.

BACKGROUND

Dear Ms. O'Leary and Mr. Steyer,

Thank you for your leadership and commitment to California. As we all look towards the future to address the massive economic impacts of the Covid-19 pandemic, we look forward to partnering with you to ensure that local communities throughout California have the tools needed to support a strong economic recovery that meets the state's housing and environmental goals. The Sacramento Area Council of Government's *Green Means Go* program is one of those tools. *Green Means Go* seeks to allocate a proportional share of existing state grant funding for public works infrastructure investments that will create more infill housing opportunities and greater mobility, while also achieving greenhouse gas (GHG) emission reductions. This is one of the few economic stimulus opportunities available that would use <u>existing</u> funds to stimulate the economy, create jobs and have immediate emission reduction benefits.

The Sacramento Area Council of Governments (SACOG) developed the *Green Means Go* pilot program after the California Air Resources Board established new SB375 GHG emission reduction targets for the state, setting a 19 percent per capita reduction target for our six county region by 2035, conditioned on the successful implementation of a pilot program that includes supportive state actions. SACOG is the association of local governments that coordinates transportation planning and housing allocations in the six-county Sacramento region. Its members include the counties of El Dorado, Placer, Sacramento, Sutter, Yolo, Yuba, and the 22 incorporated cities within. All of our member agencies – rural, suburban and urban – support *Green Means Go*.

There are existing state funds related to housing and transportation that if properly targeted could benefit our region, and all regions throughout California, and spur new infrastructure investment to restart our economy. These project-based competitive funds could be allocated to regional-based incentives that reinforce regional transportation, housing, and greenhouse gas reduction (GHG) priorities. This will also align our financial incentives with our planning priorities.

Green Means Go is a four-year pilot program to accelerate new housing and cleaner transportation options by pairing housing and mobility investments together to spur catalyst infill projects. When fully implemented, *Green Means Go* will lower GHG emissions in the Sacramento region by accelerating infill development, reducing vehicle trips, and accelerating the deployment of cleaner vehicles. It can also serve as a model for other regions throughout the state by showing how we can achieve these multiple goals through targeted regional investments driven from the bottom up by local communities.

This program is focused on urban, suburban and even rural communities where there are existing building sites on commercial corridors that could be used better to promote economic activity. Small towns, mid-sized cities, and suburban commercial corridors all have potential sites to convert to housing and create vibrate places with quality transportation, but the costs of such projects are daunting.

SUBJECT:	Approve Transit Service Plans for COVID-19 Response and Recovery

REQUESTED ACTION:

BY MOTION,

Approve a proposed plan for continuation of essential transit services with revisions, as necessary to respond to the COVID-19 pandemic

BACKGROUND

In response to the slowdown in transit ridership as a result of the COVID-19 pandemic, the El Dorado County Transit Authority (El Dorado Transit) has temporarily adjusted Sacramento Commuter, program transportation and local Dial-A-Ride services to better align with the current demands.

Subscription Dial-A-Ride transportation was suspended for attendees of the Adult Day Services program in Placerville and El Dorado Hills due to the program's closure on March 13, 2020, and contracted service was suspended to the Motherlode Rehabilitation Enterprises (M.O.R.E) program which has likewise been closed since March 16, 2020. Adjustments were also made to the other Demand Response services including Dial-a-Ride, ADA and Sac-Med due to a loss of demand when Statewide stay-at-home orders were issued.

In response to a drastic decrease in Sacramento commuter ridership, the commuter routes were reduced on March 23, 2020 from eleven (11) to four (4) buses in the morning and afternoon running on their typical holiday schedule. The modified commuter routes do not currently include the Placerville Station Transfer Center or the overflow park and ride lot at Vine Street and Mercedes Lane in El Dorado Hills. As demand increases for commuter service and economic conditions recover from the current pandemic, service to these locations may be reinstated as feasible.

DISCUSSION

While ridership has decreased on the Local Fixed Routes during the pandemic, it has not decreased as much as other services. Given the sustained demand for these essential services

El Dorado County Transit Authority May 7, 2020 Agenda and the need to maximize cost efficiency, staff proposes continuation of these services and early implementation of a few recommended changes from the <u>2019 Short- and Long-Range</u> <u>Transit Plan</u>. Analysis indicates that the proposed changes would reduce operating costs while providing the same local route coverage and frequency as currently offered. The reduced operating costs will help El Dorado Transit with the anticipated reduction in revenues from COVID-19. Staff proposes the following changes that would reduce the number of Local Fixed Route weekday buses from eight (8) to seven (7) and reduce overall vehicle service hours:

The 50 Express (50X) route will provide hourly service between the Placerville Station Transfer Center and the Iron Point Light Rail Station in Folsom using three (3) buses. It will offer direct transfers with Route 60 (Pollock Pines) and Route 20 (Placerville) at the Placerville Station Transfer Center, with Route 30 (Diamond Springs/El Dorado) at the Missouri Flat Transfer Center, and with Route 40 (Cameron Park/Shingle Springs) at the Cambridge Road Park and Ride. The route will continue to operate from 6:00 am to 8:00 pm Monday through Friday.

The <u>2019 Short- and Long-Range Transit Plan</u> states, "With the growth in ridership on the 50X route, there is an increasing benefit in extending Route 50X east to Placerville Station. This would eliminate some of the need for passengers to transfer at Missouri Flat, providing better connections between Placerville and the communities to the west."

Route 20 (Placerville) will provide hourly service in the City of Placerville by operating one (1) bus with direct transfers with the 50X and Route 60 at the Placerville Station Transfer Center. The revised route will add service to Eskaton Placerville and hourly service to the Upper Room. The route will operate from 6:30 am to 7:30 pm Monday through Friday.

Route 60 (Pollock Pines) will offer hourly service between the Placerville Station Transfer Center and the Camino/Pollock Pines area by operating one (1) bus with direct transfers with 50X and Route 20 at the Placerville Station Transfer Center. The route will operate from 7:00 am to 7:00 pm Monday through Friday.

Route 30 (Diamond Springs/El Dorado) start time will be moved from 6:00 am to 7:00 am due to low ridership during the first hour. The route will operate from 7:00 am to 7:00 pm Monday through Friday.

The <u>2019 Short- and Long-Range Transit Plan</u> states, "*The 6:00 am run of Route 30 serves an average of only 0.6 passenger boardings per weekday. Eliminating this run would reduce ridership by an estimated 150 per year but would save \$27,700 in annual operating costs.*"

Route 40 (Cameron Park/Shingle Springs) will have minor changes to improve efficiency and on-time performance. The route will continue to operate from 6:30 am to 7:30 pm Monday through Friday.

The Saturday Route 25 (Saturday Express) and Route 35 (Diamond Springs-Saturday) will have minor changes to improve efficiency and on-time performance. Both routes will continue to operate from 9:00 am to 5:00 pm.

Staff anticipates implementing the changes to the Local Fixed Routes on Monday, July 13, 2020. Maintaining the level of local route services, with the additional changes outlined above, will further improve efficiencies and on-time performance as well as position El Dorado Transit to accommodate increased fixed route demand during the early stages of the COVID-19 pandemic recovery. This includes potential for ridership demands from the reopening of modified school and childcare programs, local retail and service industries, employment centers, government offices, human services and other public spaces.

Demand for subscription Dial-A-Ride and contracted services will be dictated by the reopening of individual programs and services will be reinstated as feasible to best address these priority services.

In the later stages of the recovery when higher-risk and/or regional workplaces reopen, and Statewide orders are lifted more broadly for vulnerable populations, public Dial-A-Ride and Sacramento commuter demand may gradually increase. Staff anticipates an ongoing public outreach and analysis process to determine how best to return these services to former levels within fiscal constraints. Like the approach taken with the local route changes outlined previously, opportunities to improve efficiency, on-time performance and customer service will be explored throughout the recovery process with the goal of returning to prior ridership levels and beyond.

FISCAL IMPACT

The fiscal impact of the emergency reductions in Demand Response and Commuter services due to COVID-19 are still being analyzed and will be reported in future Board agenda items.

The proposed reduction in the number of Local Fixed Route buses is expected to reduce annual operating costs by an estimated \$317,855 and the reduction in one hour of service on Route 30 (Diamond Springs/El Dorado) is expected to reduce annual operating costs by an estimated \$27,700.

A phased, fiscally constrained approach to reinstatement of all remaining services will be employed throughout the recovery from the present public health crisis.

SUBJECT:	Personnel Allocation and Final Budget Adoption Process for Fiscal Year (FY) 2020/21

REQUESTED ACTION:

BY MOTION,

- 1. Direct the Executive Director to determine levels of staff attrition for potential reductions in labor force among represented and unrepresented employee groups
- 2. Set a Special Meeting and Public Hearing on July 9, 2020 to adopt the final Operating and Capital Budgets for FY 2020/21

BACKGROUND

In response to immediate and significant ridership losses, program closures and state-wide public health directives to support social distancing/sheltering in place due to the COVID-19 health emergency, the El Dorado County Transit Authority (El Dorado Transit) suspended some services beginning in early March. Additionally, El Dorado Transit expects a significant and possibly long-term shortfall of major revenue sources requiring substantial reductions in expenditures across all major operating budget categories. An interim transit service plan, reflecting the current and additional proposed public transit service reductions, is presented for approval elsewhere in this agenda.

El Dorado Transit typically adopts an annual Personnel Allocation Plan by resolution prior to the adoption of a final Operating Budget in June for the following fiscal year. The <u>Bylaws of the El</u> <u>Dorado County Transit Authority</u> require the Executive Director to propose final Operating and Capital budgets to the Board on or before June 15th of each year with final adoption required by July 15th.

On April 2, 2020, following the recommendation of the Ad Hoc Budget Review Committee, the Board adopted the FY 2020/21 Preliminary Operating Budget including revisions. At that time, it was understood that future economic developments related to the COVID-19 pandemic would affect operating revenue streams but it was early in the crisis and the Committee agreed to take a status quo approach to the preliminary budget until more information became available.

DISCUSSION

The unprecedented COVID-19 public health crisis and corresponding socioeconomic interruptions brought a sudden and comprehensive stop to otherwise positive ridership demand and revenue trends. Since mid-March when stay-at-home orders were issued locally and Statewide, El Dorado Transit has experienced a seventy-five percent (75%) decrease in average daily ridership compared to the preceding nine (9) month period. In addition to the resulting loss of fare revenue, vital State funding sources derived from a percentage of local retail sales tax revenue could decline by upwards of fifty-five percent (55%) or more over the coming months. These Transportation Development Act (TDA) funds make up approximately seventy-two percent (72%) of El Dorado Transit's annual operating budget. At this point, it is unknown exactly what the long-term effects will be to local transit service demand and what the losses of operating revenue from the COVID-19 pandemic will be, but reasonable estimates of the budget shortfall from just TDA funding losses could be more than \$3.2 million, representing approximately one-third (1/3) of the adopted preliminary operating budget.

Given the operational and fiscal consequences of the COVID-19 crisis and the uncertainty of future economic conditions, El Dorado Transit is compelled to initiate significant reductions to the workforce to maintain the financial viability of the agency until such time as demand for transit service returns and essential revenue streams return to their former levels. The FY 2019/20 Allocation Table is attached for reference and includes a maximum allocation of sixty-three (63) full-time equivalent (FTE) staff positions. Achieving an appropriate and fiscally sustainable staffing level during and after the current pandemic will likely require separations and/or elimination of positions, including full and part-time Transit Operators and unrepresented employees across multiple departments. The final number of necessary personnel allocations will likely be adjusted based on workforce reductions achieved through attrition and potentially readjusted based on operational need as it develops over the coming months.

Pursuant to Article 21 of the current Memorandum of Understanding Between the El Dorado County Transit Authority and the Operating Engineers Local Union No. 3 (MOU), formal notice must be served on Transit Operators that may be affected by a reduction in force authorized by the Board. Such notice must be served at least thirty (30) calendar days prior to the effective date of separation and must include the reasons for the actions, rehire or restoration rights and appeal rights. Prior to providing such notices, El Dorado Transit should determine what, if any, staff reductions may be achieved through attrition within the Transit Operator classification prior to initiating permanent layoffs. If authorized, staff will initiate discussions with individual employees that may result in voluntary separations, demotions and/or retirements, thus altering the final reductions necessary within specific classifications. After reasonable attrition is determined, staff will present a recommendation regarding the number of positions proposed for reduction at the Board's June meeting. A final FY 2020/21 Allocation Plan will then be presented for approval in conjunction with final budget adoptions, proposed for July 9, 2020. As such, staff recommends the following Board actions at this time:

- Provide the Executive Director with guidance and direction to begin discussions with individual, represented and unrepresented employees to determine what reductions may be facilitated through voluntary separations, demotions or retirements. After reasonable attrition is determined, staff will return to the Board for guidance and direction regarding further reductions pursuant to MOU Article 21. If necessary and after Board direction at the June board meeting, and in coordination with the Operating Engineers Local Union No. 3, staff will move to formal notice of affected Transit Operators per the terms of the current MOU.
- Set a special July 9, 2020 Board meeting to hold a public hearing and adopt the final FY 2020/21 Operating and Capital Budgets. If authorized, staff will propose a final FY 2020/21 Personnel Allocation Plan for Board adoption, prior to or in conjunction with the Operating Budget, reflecting the outcomes of all the voluntary personnel actions negotiated to date and subsequent reductions in force deemed necessary to sustain essential services.

FISCAL IMPACT

The fiscal impact of the recommended actions will vary based on potential workforce reductions achieved through attrition. Monthly revenue losses from vital State funding sources will be realized beginning as early as May 2020 and continue throughout the economic recovery, making future financial impacts difficult to predict. In addition, staffing adjustments may be needed if services are reinstated to meet increased demand from a comprehensive reopening of businesses, programs and services in the interim.

All costs associated with the proposed personnel actions/authorizations and related staffing changes will be included in the final FY 2020/21 Operating Budget and Allocation Plan, anticipated for adoption on July 9, 2020.
